

NOTES

- 1. Call out any other permanent structures and their height & location (poles, antennae, signs)
- 2. BLDG height must include absolute highest point (consider poles, antennae or ac units on roof)
- 3. BLDG site elevation must be finished floor elevation
- 4. Crane height must be the lowest practical height necessary to complete work (not maximum crane height)
- 5. Coordinates must be in Degrees, Minutes, Seconds format
- 6. Crane Envelope of Maneuverability Example can be created/hand drawn on Site Plans, Aerials, GoogleEarth Screenshots, or other project drawings
