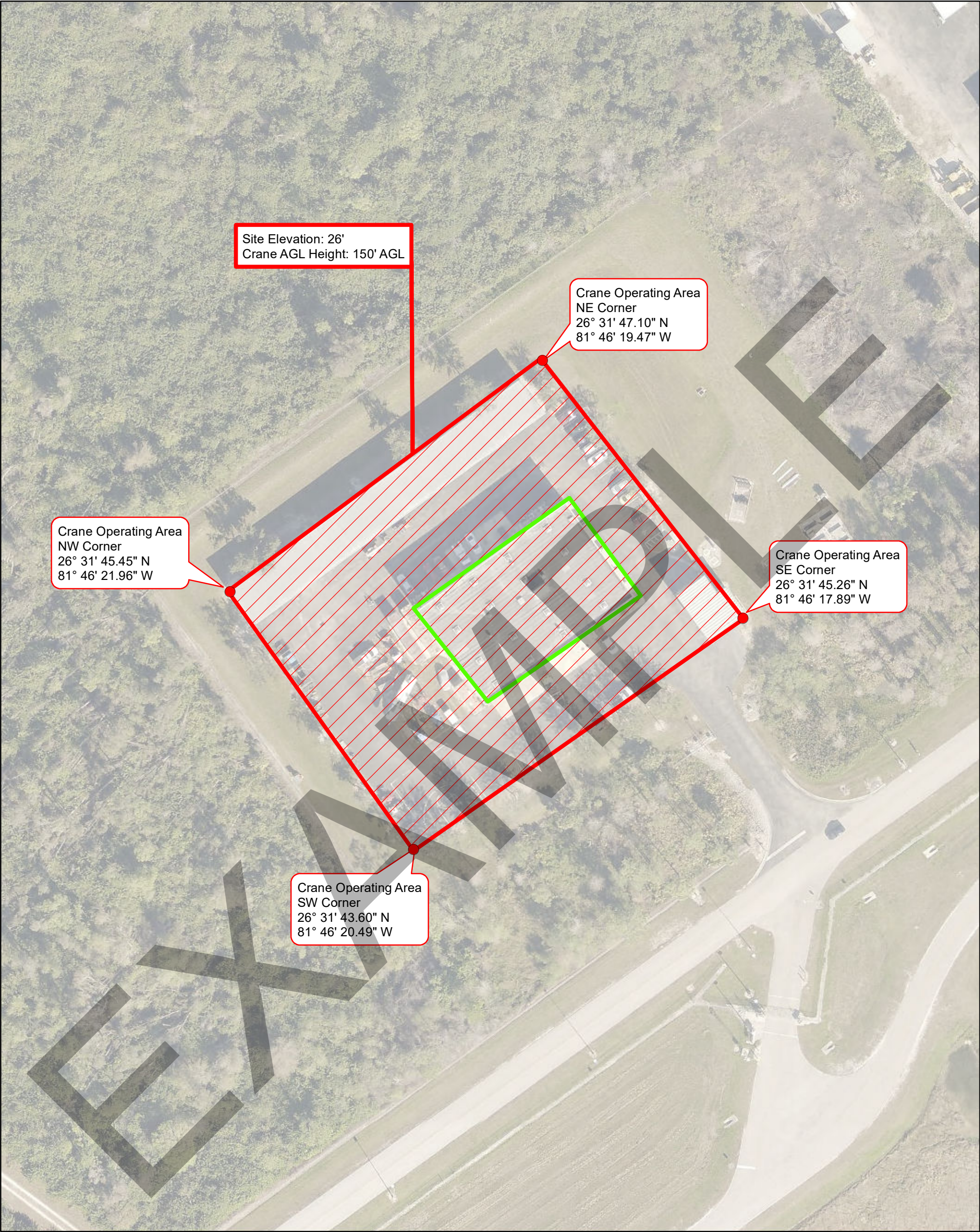

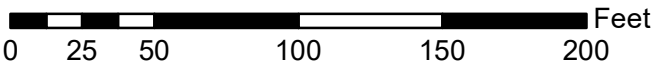
Crane Envelope of Maneuverability Example

- 1. Elevation must be existing site elevation
 - 2. Crane height must be the lowest practical height necessary to complete work (not maximum crane height)
 - 3. Coordinates must be in Degrees, Minutes, Seconds format
 - 4. Crane Envelope of Maneuverability Example can be created/hand drawn on Site Plans, Aerials, GoogleEarth Screenshots, or other project drawings
